CALL TO ORDER

Chairman Bicknase called the meeting to order at 6:00 p.m.

APPROVAL OF AGENDA

1. To approve the agenda for the June 9, 2016 regular meeting.

OLD BUSINESS

2. Approval of the minutes of the Commission meetings of April 13 and May 18, 2015.

Kindt moved, with Schipper seconding, to approve the minutes of the April 13 and May 18 Commission meetings. The motion was approved by a unanimous vote.

NEW BUSINESS

3. Discussion of the Planned Unit Development Conditional Use Permit and Preliminary Plan Applications for Greyhawk Estates, located in the SE¼ of Section 1, T99N, R50W, 5th P.M., City of Harrisburg, Lincoln County, South Dakota.

McMahon reported that the City Council agenda for June 15 will contain an item to direct the PUD and Preliminary Plan be sent back to the Planning Commission for further review, revision, and a new recommendation by the Commission to the Council. The Planning Commission will hold a special meeting at 6:00 p.m. on Tuesday, June 30 at the Liberty Elementary School Board Room to consider these items. The interested neighbors will be invited to the special meeting. McMahon also distributed copies of the revised Preliminary Plan.

4. Discussion of revised off-street parking regulations.

The Commission extensively discussed options for revising the off-street parking regulations. The consensus of the Commission is to allow parking of non-motorized vehicles (trailers, pull campers, boats, snowmobiles on trailers) in rear yards if parked on a parking pad that consists of pavement, pavers, or crushed rock. Parking in side yards will be allowed, but only on concrete or asphalt pavement. McMahon is to redraft the revised regulations and present them to the Commission at their July meeting.
