6:05pm – A Public Hearing was held to accept public input on a request to rezone 91.96 acres of the Devitt Farms Addition (SW¼ less parts sold of Section 36, T100N, R50W, 5<sup>th</sup> P.M., City of Harrisburg, Lincoln County, SD) from General Business and Natural Resource Zoning Districts to: 22.97 acres of Natural Resource District, 39.49 acres of R-1 Single-Family Residential District, 1.56 acres of R-2 Multi-Family Residential District, and 27.94 acres of General Business District.
