He also asked that the council take into consideration the effect on the home builders when discussing the rate study recommendation of sewer connection fee increases.

Lincoln County Commissioner Joel Arens informed council of the upcoming referendum election on July 27, 2021 with absentee voting starting June 11, 2021. He also shared that Lincoln County is going through a comprehensive study in regard to courthouse space needs and the redistricting of the county commissioner districts due to growth.

Business Item 6. Water Reclamation Facility Force Main Project

- a) Change Order #2 Deduct of \$168,649.66. Motion Tank, seconded Maxwell to approved and authorize the mayor to sign Change Order #2 for the Water Reclamation Facility Force Main Project in the deduct amount of \$168,649.66. Upon roll call, all members present in favor.
- b) Pay Application #9 and Final. Motion Maxwell, seconded Tank to approve and the 9th and final pay application for the Harrisburg Forcemain Water Reclamation Facility in the amount of \$8,582.60. Upon roll call, all members present in favor.

Business Item 7. Consider Quote from Benders Sewer and Drain to Video Inspection of Storm Sewer Lines. Quote is more than budgeted amount due to larger pipe sizes in this area, supplemental in the storm sewer fund if needed for additional costs. Motion Anez, seconded Maxwell to approve the quote from Benders Sewer and Drain to video inspect storm sewer lines in the amount of \$41,198.89. Upon roll call, all members present in favor.

Business Item 8. Consider Proposal for Additional Testing on Dakota Aquifer. Testing of the quality of the water in the Dakota Aquifer will determine future water source. Motion Tank, seconded Maxwell to approve and authorize the mayor to sign the contract with LRE Water for the additional testing on Dakota Aquifer in than amount not to exceed \$7,700.00. Upon roll call, all members present in favor.

Business Item 9. Consider Engineering Proposal for Willow St. Arterial Road Preliminary Design from Southeastern Ave. to Railroad Ave. from HDR. Study will help define traffic needs on the east side due to additional development. Motion Maxwell, seconded Anez to approve and authorize the mayor to sign the engineering proposal from HDR for the Willow St. Arterial Road Preliminary Design from Southeastern Ave to Railroad Ave. in the amount not to exceed limit of \$70,000. Upon roll call, all members present in favor.

Business Item 10. Consider Engineering Proposal for Design of Trunk Sewer along 9 Mile Creek Tributary (Creekside/Mills Creek area) from Banner Engineering. Originally planned to construct oversized pipe in development however studies show more depth is needed to service a greater area.Motion Kindt, seconded Maxwell to approve and authorize the mayor to sign the engineering proposal from Banner for the design of trunk sewer along 9 Mile Creek Tributary (Creekside/Mills Creek area) in the amount of \$104,810. Upon roll call, all members present in favor.

Public Presentation. AE2S (Sarah Sesselman) Harrisburg Sewer Rate Design & Revenue Adequacy Evaluation Results and Recommendations. The sewer rate study recommends 0% rate adjustments through 2032, to annually review rates and revenue adequacy model annually, modify surcharges as a function of actual flow and account growth, track revenue generated and adjust as appropriate, implement incremental sewer connection fee increase in year 2022 and focus on public education of rate structure and citywide benefit of capital improvements. Presentation slides available on city website or at city hall.

Mayor Wenck thanked everyone for their hard work during Harrisburg Days to make it a successful event.

With no further business, a motion was made by Tank, seconded Maxwell to adjourn the city council meeting at 7:33 pm. Upon roll call, all members present in favor.
