2022 - Harrisburg Multi Family Residential City Water and Sewer Rates (Multi Family <u>living units</u> are calculated by applying a .08 reduction multiplier) If a building is a 6 unit building it would be considered 5 living units when calculating bills.

The base monthly water rate is determined by the size of meter for the building, for 5/8" and ¾" meters the base rate is \$9.58, for a 1" meter it is \$14.17, for a 1.5" meter it is \$25.66, and 2" is \$39.44 plus the volume rate of \$4.60

per one thousand gallons of water used. The water rate also includes:

WSC-02 RES (Surcharge) of \$.65 per each 1,000 gallons used for the repayment of a surcharge revenue bond loan for our Lewis & Clark Rural Water System distribution line maturing at the end of 2028.

WSC-03 RES (Surcharge) of \$.88 surcharge per each 1,000 gallons used for the repayment of a Water System Revenue Bond to pay for the elevated water storage tower and water main maturing in 2031

WSC-04 (a base fee surcharge) of \$4.56 for the repayment of revenue bonds for water system upgrades on SD HWY 115 maturing at the end of 2039.

Sewer rates for residential multi-family homeowners shall pay a base monthly fee of thirty-eight dollars and seventy-one cent (\$38.71) per month (the "Base Fee") per living unit, plus nine dollars and fifty cents (\$9.50) per one thousand gallons of water used per month (The "Volume Rate").

Each living unit shall pay a base surcharge (S<u>SC RES-03) of \$4.51</u> to repay a surcharge revenue bond for the construction of 10.6 miles of 16 inch force main to pump wastewater to Sioux Falls for treatment maturing 2042. Base surcharge (<u>SSC- RES-04) rate of \$1.54</u> to repay a surcharge revenue bond for the Columbia Basin sanitary sewer interceptor maturing in 2034.

Base surcharge (SSC- RES-06) rate of \$6.18 to repay a surcharge revenue bond for the wastewater treatment plant land.

Base surcharge **(SSC-RES-07)** rate of \$39.41 to repay a surcharge revenue bond for the wastewater treatment plant.

There is also a street light service fee on each bill calculated at \$1.50 per dwelling unit per month.
