Harrisburg City Council Meeting Minutes

The regular meeting of the City Council was called to order on July 5th, 2016, at 6:00 pm, with Mayor Julie Burke-Van Luvanee presiding. Council members present were Ryan Olson, Allison Sanderson, and Ryan Berg. Absent was Ryan Wolbrink. Also present from the city were Mary McClung, Andrew Pietrus, and Michael McMahon. A list of all others in attendance is on file at the city office. Motions: All motions were by majority vote and approved unanimously by those members present unless otherwise indicated.

Pledge of Allegiance was recited.

Discussion was held on amending the Lewis & Clark Regional Water System's ARCA to allow the use of the Capital Improvement Reserve Fund prior to the entire "System" being completed. If approved by all 20 members of Lewis and Clark the amendment would allow them to access funds prior to the full completion of the system. Once money is put into the three reserve funds the ARCA prevents moving the money from one reserve fund to another. The "System" has been operational for a while now and there has come a time where these funds could or should be used to replace some of the "components of the System" (it's intended purpose) but the ARCA prevents the use of those funds until the entire system is completed, the amendment would remove the stipulation that the entire "System" be completed prior to use of the CIRF. The consensus of the Harrisburg City Council is to amend the Lewis & Clark Regional Water System's ARCA.

Discussion held on a request to change the traffic light on Willow Street by the high school entrance back to a green/yellow/red signal as it currently is flashing yellow/red and doesn't allow for a safe crosswalk to and from school. No action taken at this time.

Motion Berg to remove to take Utility Service Maintenance Plan for the Water Towers from the table; seconded Sanderson. The Maintenance Program includes annual inspections (either visual or washouts), emergency services, all repairs, mixers for both towers, exterior paintings, interior renovations, and the entire cost of which is spread out over the years of the contract. Nichole Grasma with USG was present to answer questions that the council had regarding the services provided. Brown had some additional concerns with the contract draft he had reviewed. Motion Berg to retable Utility Service Maintenance Plan for the Water Towers, seconded Sanderson.

Public hearing for the proposed Resolution of Necessity 2016-08 for the Devitt Farms Regional Detention Facility was held at approximately 6:20 pm. Brown, Stockwell Engineers reviewed the project with those present. Public comment from Sweetman Const. Co., Hurco, Showplace and Harrisburg High School representatives was received and discussion was held. Public comment was closed at 7:33 p.m.

Motion Olson to approve Resolution 2016-08 Resolution of Necessity for the Special Assessment of the Devitt Farms Regional Detention Facility with amendment, seconded Sanderson. Amendment: BE IT FURTHER RESOLVED that the assessments shall reflect a credit given for prior payments by the assessed property owners into the Stormwater Drainage Fund as of the date of the adoption of this resolution.

RESOLUTION NO. 2016-08 RESOLUTION OF NECESSITY

WHEREAS, the City Council of the City of Harrisburg, South Dakota (the "City") has declared that the convenience and necessity has arisen to construct a regional storm water detention facility at the Devitt Farms development within the City of Harrisburg, Lincoln County, South Dakota;

WHEREAS, the City has published and mailed notices to property owners as required by South Dakota Codified Laws; and

WHEREAS, the City is ready to proceed with the project and again declare the necessity to make the improvements.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Harrisburg, South Dakota, at a regular meeting thereof held at the Liberty School Board Room, 200 East Willow Street, Harrisburg, South Dakota at 6:00 o'clock p.m. on the 5th day of July 2016, that the convenience and necessity has arisen to

construct a regional storm water detention facility at the Devitt Farms development within the City of Harrisburg, Lincoln County, South Dakota. Such properties affected being hereinafter named:

See attached Exhibit A.

BE IT FURTHER RESOLVED, that the material to be used in the project shall be according to plans and specifications prepared by engineers for the City of Harrisburg and on file in the office of the Finance Officer and open to public inspection and incorporated hereby.

BE IT FURTHER RESOLVED, that the total estimated cost of the project is \$905,721. The total costs shall include the contract price and all engineering, inspection, publication, fiscal, legal, and all other expenses incidental thereto. The costs of the improvements and all other expenses incidental thereto shall be assessed against all assessable lots and tracts of land within the contributing basin who do not have onsite detention facilities in place or an approved development plan indicating onsite detention facilities. The amount that each benefitted property will be assessed will be based on the area (acres) that are included in the watershed basin, and the land use as shown on the Future Land Use Map in the City of Harrisburg's Comprehensive Plan.

BE IT FURTHER RESOLVED that the City may by subsequent resolution assume a portion of the costs of the improvements set out above.

BE IT FURTHER RESOLVED, that the assessments will be divided into twenty equal annual installments which shall be payable under Plan One, collection by the County Treasurer, as set forth in SDCL §9-43-102, et seq., and that all deferred installments shall bear interest at such rate as shall be determined by the City Council, but not in excess of six percent (6%) per annum.

BE IT FURTHER RESOLVED, that the assessed property owners shall be given the option to elect prior to the passage of the special assessment roll to have the assessments divided into five equal annual installments which shall be payable under Plan One, collection by the County Treasurer, as set forth in SDCL §9-43-102, et seq., and that all deferred installments shall bear interest at such rate as shall be determined by the City Council, but not in excess of four percent (4%) per annum.

BE IT FURTHER RESOLVED that the assessments shall reflect a credit given for prior payments by the assessed property owners into the Stormwater Drainage Fund as of the date of the adoption of this resolution.

BE IT FURTHER RESOLVED that the contractors who undertake to perform the work of construction herein provided for shall be paid in cash from City funds or borrowed funds that will be refunded, upon completion of the project, with the sale of special assessment bonds.

BE IT FURTHER RESOLVED, that the Finance Officer is directed to take such action as is necessary to carry out the intent of the resolution.
