Motion Wolbrink to approve the engineering agreement for professional services from Stockwell Engineers for South Cliff Avenue Drainage Improvements in the amount of \$7,240.00, seconded Berg.

Motion Wolbrink to approve Stockwell Engineers to proceed with informal bid request process for the South Cliff Avenue Drainage Improvements project, seconded Olson.

Kiel Dailey was present to discuss his residence in Legendary Estates. Discussions will continue between Dailey, city administrator, city engineer and the city attorney.

Motion Berg to approve eliminating the August 1st, 2016, meeting and authorizing the Finance Officer to pay all bills received by August 10th and to have the Mayor sign these checks, seconded Sanderson.
