Business Item 1. Tabled Item: Banner Associates, Inc. Proposal. Motion Berg, seconded Wolbrink to remove Banner Associates, Inc. proposal from the table for further discussion. The original scope of services that was presented was cut back. Motion Wolbrink, seconded Berg to approve the proposal from Banner Associates, Inc. to complete a value engineering study of the Wastewater Facilities Plan in the amount of \$18,500.

Former SD House of Representative and SD Senator from District 19 Frank Kloucek was present and invited all to the 2018 Czech Days and expressed to the council that having good zoning regarding buffer zones for wind farms and large farming operations is important. He also read a proclamation honouring Mayor Burke-VanLuvanee.

Business Item 2.Quotes for Curb and Gutter, Valley Gutter and Sidewalk Repairs. Two informal quotes were received from Tom Crete Concrete and BHI. Motion Berg, seconded Wolbrink to approve the quote from Tom Crete Concrete for curb and gutter, and valley gutter in the amount of \$41,522.40.

Business Item 3. Columbia Street N., Foundation Drive and Central Parking Lot.

a) Change Order #1 – Includes RFP #1 Central Park Parking Lot Electrical and RFP #3 Asphalt Existing Gravel Path on large pond in Devitt Development - Motion Wolbrink, seconded Sanderson to approve Change Order #1 to the Columbia Street, N, Foundation Drive and Central Parking Lot project in the amount of \$79,854.00 using \$17,400.00 from within the 2017 park fund budget for the central park parking lot electrical and using \$62,454.00 of cash on hand in the general fund for the asphalting of the existing gravel path on the large pond within the Devitt property.

b) Change Order #2 – RFP #2 Foundation Drive Gravel Roadway – Motion Wolbrink, seconded Berg to approve Change Order #2 to the Columbia Street N., Foundation Drive and Central Parking Lot project in the amount of \$24,091.25 using money budgeted within the 2017 park fund.

Business Item 4. GeoTek Engineering & Testing Services Proposal for N. Columbia Street Project. Motion Sanderson, seconded Wolbrink to approve the proposal from GeoTek Engineering & Testing Services for the N. Columbia Street project not to exceed \$3,750.00.

Business Item 5. Devitt Regional Detention Pond.

- a) Pay Request #3 Motion Wolbrink, seconded Berg to approve Pay Application #3 from Dakota Constructors in the amount of \$194,617.53 for the Devitt Regional Detention Pond improvements.
- b) Change Order #2 Motion Berg, seconded Sanderson to approve Change Order #2 for the Devitt Regional Detention Pond project in the amount of \$4,572.15 for NEMA 3R enclosures for the fountains and fountain light controls.

Business Item 6. Floating Pump System. Motion Wolbrink, seconded Sanderson to approve the purchase of a Floating Pump System for \$1,895.00 plus any shipping charges incurred.

Business Item 6.5. Compost Site will now accept plants and garden waste.

Business Item 7. Job Description – Seasonal Part Time Compost Supervisor. Motion Sanderson, seconded Berg to approve the job description for the Seasonal Part Time Compost Supervisor as prepared.

Business Item 8. New Hire of Seasonal Part-time Compost Supervisor. Motion Berg, seconded Wolbrink to approve hiring Brian Hassler for the Season Part-time Compost Supervisor at a pay rate of \$11.00 per hour.

Business Item 9. Employee Salary Adjustment. Motion Wolbrink, seconded Sanderson to approve a salary adjustment for Dan Fink at a new rate of \$67,139.73 per year beginning with the pay period beginning July 3, 2017.

Business Item 10. Executive Session Pursuant to SDCL 1-25-2(3). Motion Sanderson to enter into an executive session pursuant to SDCL 1-25-2(3) at 7:05pm. Mayor declared executive session over at 7:16 pm.
