

CITY OF HARRISBURG ORDINANCE #2017-07,  
TO AMEND TITLE 3, HEALTH AND SANITATION,  
OF THE REVISED MUNICIPAL ORDINANCES

BE IT ORDAINED by the City Council of the City of Harrisburg as follows:

**ARTICLE I – PURPOSE AND JURISDICTION**

**SECTION 1 – PURPOSE.**

Ordinance #2017-07 is an ordinance to amend the Title 3 of the Revised Municipal Ordinances of the City of Harrisburg with corrections and updates. The City Council of the City of Harrisburg has deemed these regulations and controls to be reasonable and reasonably related to the purpose of promoting the health, safety, and general welfare of the City of Harrisburg.

**SECTION 2 – JURISDICTION.**

This Ordinance shall govern all territory within the statutory jurisdiction of the City of Harrisburg, South Dakota.

**SECTION 3 – SEVERABILITY AND SEPARABILITY.**

Should any Article, Section, Subsection, or Provision of this Ordinance be found to be or declared invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity or constitutionality of the Ordinance as a whole or any part thereof, other than the portion so declared to be invalid or unconstitutional.

**ARTICLE II – AMENDMENTS TO TITLE 3, HEALTH AND SANITATION**

A. Amend Chapter 3.0102.E to read:

Motor vehicles, snowmobiles, motorcycles, and other mechanical devices used for transportation which are not stored inside a building and which are not licensed or in running condition, or which remain unmoved for a period in excess of ~~fourteen~~ seven days except when such motor vehicles and devices are stored, collected, piled, or kept in a salvage yard, used-car-parts yard, body shop, auto repair shop, towing service, auto sales, or other vehicle-related business;

B. Add Chapter 3.0102.U, to read:

No person shall abandon, leave, or place, in any street, alley, right-of-way, sidewalk, public way, lot, park, square, pond, stream, stream bed, creek, creek bed, drainage ditch, canal, basin, or any public enclosure any grass clippings or other vegetation of any kind or snow or ice;

C. Amend Chapter 3.0107.B to read:

No person, ~~while a driver or passenger in a vehicle,~~ shall throw or deposit litter or yard waste upon any street or other public place or upon private property within the City.

BE IT FURTHER ORDAINED by the City Council of the City of Harrisburg that this Ordinance shall become effective in accordance to law.
