CITY OF HARRISBURG ORDINANCE #2017-08, TO AMEND TITLE 7, TRAFFIC CODE, OF THE REVISED MUNICIPAL ORDINANCES

BE IT ORDAINED by the City Council of the City of Harrisburg as follows:

ARTICLE I - PURPOSE AND JURISDICTION

SECTION 1 – PURPOSE.

Ordinance #2017-08 is an ordinance to amend the Title 7 of the Revised Municipal Ordinances of the City of Harrisburg with corrections and updates. The City Council of the City of Harrisburg has deemed these regulations and controls to be reasonable and reasonably related to the purpose of promoting the health, safety, and general welfare of the City of Harrisburg.

SECTION 2 - JURISDICTION.

This Ordinance shall govern all territory within the statutory jurisdiction of the City of Harrisburg, South Dakota.

SECTION 3 – SEVERABILITY AND SEPARABILITY.

Should any Article, Section, Subsection, or Provision of this Ordinance be found to be or declared invalid or unconstitutional by a court of competent jurisdiction, such decision shall not affect the validity or constitutionality of the Ordinance as a whole or any part thereof, other than the portion so declared to be invalid or unconstitutional.

ARTICLE II - AMENDMENTS TO TITLE 7, TRAFFIC CODE

A. Amend Chapter 7.0501.J to read:

No person shall park any recreational vehicle on any street within the City for a period longer than seventy-two (72) forty-eight hours. Recreational vehicle(s) shall be tagged by a law enforcement officer and a warning issued to remove within seventy-two (72) twelve hours. Failure to do so will result in removal by the City at the owner's expense. For purposes of this Section, recreational vehicle is defined to include, but shall not be limited to, the following:

B. Add Chapter 7.0501.L to read:

Parking of any inoperable or unlicensed vehicle on any City street.

C. Amend Chapter 7.0706 to read:

Operation on Public Ground and Streets Prohibited. No person shall operate a snowmobile on any public school grounds, public sidewalks, park property, park, roads, playgrounds and recreational areas within the City. Snowmobiles may be operated over snow-covered highways, streets and alleys within the City limits but only for emergency use as defined in 7.0711 or when the operator

must travel upon such for purposes of leaving the City and/or when returning to his residence from outside the City. The operator when using any public street, highway or alley in accordance with the above restrictions, shall use the most expeditious and direct route.

BE IT FURTHER ORDAINED by the City Council of the City of Harrisburg that this Ordinance shall become effective in accordance to law.
