RESOLUTION NO. 2020-04

A RESOLUTION PERMITTING OPEN CONTAINERS IN A SPECIFIED AREA OF HARRISBURG DURING SPECIFIED TIMES AND DATES.

WHEREAS, the City of Harrisburg (the "City") has passed ordinance 5.0102 that reads as follows:

<u>5.0104 Open Containers</u>. It shall be unlawful to consume any beer or alcoholic beverage or to possess any glass, can or other container containing beer or any alcoholic beverage on which the seal has been broken, in any public place, vacant building, automobile, street, alley, sidewalk or place of amusement or business establishment not authorized to sell beer or alcoholic beverages, unless approved by the City Council.

WHEREAS, the City has determined that it shall permit the consumption of alcoholic beverages on specific City streets at specific times during the Sioux Nation Chapter Leathernecks event.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Harrisburg, South Dakota, that it shall permit the consumption of beer or alcoholic beverages on specific streets at specific times subject to the requirements of this resolution.

BE IT FURTHER RESOLVED that consumption shall only be permitted on the following public places, portions of streets, and their adjacent sidewalks and right of ways:

• Main and Elm Streets between Railroad and Columbia Street, Prairie Street between Willow Street and Maple Street

BE IT FURTHER RESOLVED that no open container shall be permitted past barriers erected on the above streets and their adjacent sidewalks and right of ways;

BE IT FURTHER RESOLVED that only open containers purchased from establishments or permit holders licensed pursuant to SDCL 35-4-2(4) or SDCL 35-4-124 shall be permitted on the above streets and their adjacent sidewalks and right of ways;

BE IT FURTHER RESOLVED that open containers shall only be permitted on the following dates and times:

- June 26, 2020, 12:00pm June 27, 2020, 1:00am;
- June 27, 2020, 12:00pm June 28, 2020, 1:00am;

BE IT FURTHER RESOLVED that no glass containers containing beer or any alcoholic beverage shall be permitted on the above streets and their adjacent sidewalks and right of ways; and

BE IT FURTHER RESOLVED that the City and/or law enforcement may in its sole discretion reduce the area where open containers are permitted and shorten the time during which open containers are permitted.

RESOLUTION NO. 2020-03

A RESOLUTION REVISING SUBDIVISION AUTHORITY BOUNDARY OUTSIDE OF THE MUNICIPAL LIMITS BETWEEN THE CITY OF SIOUX FALLS AND THE CITY OF HARRISBURG.

WHEREAS, the City of Harrisburg by Resolution 2016-14 and the City of Sioux Falls by Resolution No. 32-17 have agreed to a subdivision authority boundary line as follows: Beginning at the intersection of the centerlines of 479th Ave. and 271st St., then west along the centerline of 271st St. until the intersection of centerlines of 271st St. and Western Ave., then south along the centerline of Western Ave. until the centerlines of Western Ave. and 272nd St., then west along the centerline of 272nd St. until the endpoint at the intersection of centerlines of 271st St. and the center of the right-of-way for Interstate 29;

WHEREAS, the City of Harrisburg will have the capability to provide sanitary sewer service to areas south of 271st St. and east of Interstate 29 as a result of a trunk sewer project planned for construction in the year 2020; and

WHEREAS, the City of Harrisburg has determined that it is necessary to revise the current subdivision authority boundary.

NOW, THEREFORE, BE IT RESOLVED by the Harrisburg City Council that the subdivision authority boundary line between the City of Harrisburg and the City of Sioux Falls shall be amended as follows: Beginning at the intersection of the centerlines of 479th Ave. and 271st St., then west along the centerline of 271st St. until the endpoint at the intersection of centerlines of 271st St. and the center of the right-of-way for Interstate 29, as shown on the attached map and made part of this resolution for reference.
