#1) Parcel #270.16.08.015: Lot 15 of Block 8 Harvest Acres Addition Harrisburg

Mr. Stanga feels that the building value should be lowered to \$160,820 due to purchase price and the land adjacent to the rear of the property is business type use, not residential. The building is assessed at \$327,960 which he feels was appraised to high, The County completed an inspection on 3/12/2020 and the lower level finish is only partially framed. They recommended lowering the building structure assessment to \$275,310. Motion Heerde, seconded Berg on Parcel 270.74.16.015 for Tyler Johnson at 604 Brannon Drive to leave the assessed value for land at \$35,990 and to change the building structure value to \$275,310 for a total assessed value of \$311,300. Upon roll call vote, all in favor. Change made.
