RESOLUTION NO. $\underline{2014-18}$ RESOLUTION OF NECESSITY TO REBUILD SIDEWALK

WHEREAS, the City Council of the City of Harrisburg, South Dakota (the "City") has the power pursuant to SDCL 9-46 to deem it necessary to construct, rebuild, or repair any sidewalk, and to notify owners of lots adjoining such sidewalk to construct, rebuild, or repair the sidewalk at owner's expense within the time designated by the City; and

WHEREAS, if such sidewalk is not constructed, reconstructed, or repaired in the manner and within the time prescribed by the City, the City may cause the work to be done by day labor or by job and assess the costs thereof against the lots fronting or abutting upon the sidewalk so constructed, reconstructed, or repaired.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Harrisburg, South Dakota, at a regular meeting thereof held at the Liberty School Community Room, 200 East Willow Street, Harrisburg, South Dakota at 6:00 o'clock p.m. on the 17th day of November, 2014, that the convenience and necessity has arisen to rebuild the sidewalks along 206 and 210 Main Street within the City of Harrisburg, Lincoln County, South Dakota. Such properties affected being hereinafter named:

BE IT FURTHER RESOLVED, that in the event that the owners of said properties do not rebuild and replace the sidewalks adjacent to their properties by May 15th, 2015, the City shall pursuant to SDCL 9-46 cause the work to be done and the cost thereof shall be assessed against the lots fronting or abutting upon the sidewalk so constructed, reconstructed, or repaired.

BE IT FURTHER RESOLVED, that notice of this resolution shall be given to the owners of said properties in writing and either be served personally or by return receipt mail, on each owner or by publication once in each week for two consecutive weeks.
