Adrienne McKeown presented the Harrisburg Chamber of Commerce 2022 Subsidy Request.

Business Item 1. Consider Heart of Harrisburg Capital Campaign Contribution. Al Doeve, Brandon Lane and Adam Walsh were present to answer any questions regarding the contribution request. Motion Anez, seconded Maxwell to approve a contribution to the Heart of Harrisburg Capital Campaign for 2022 in the amount of \$100,000 contingent upon the full split of the Harrisburg Economic Development Corporation and Harrisburg Chamber Boards and additional future funding of \$550,000 contingent on land purchase for development. Upon roll call, all members present in favor.

Business Item 2. Consider Harrisburg Water Reclamation Site Planned Service Agreement with Krier & Blain for HVAC Systems. Motion Tank, seconded Maxwell to approve the three-year HVAC service agreement with Krier & Blain for the Water Reclamation Facility, first year amount \$5,541.00. Upon roll call, all members present in favor.

Business Item 3. Award Slurry Seal to Asphalt Surfacing Company. City of Sioux Falls solicited bids for the 2022 Slurry Seal Project for the City of Sioux Falls and surrounding areas. Three bids were received for the overall project. City of Harrisburg's portion of the bids were: Asphalt Surfacing Company in the amount of \$109,996.00; Asphalt Technologies Corporation in the amount of \$115,625.55; and Missouri Petroleum Products in the amount of \$132,252.80. Motion Maxwell, seconded Tank to award the 2022 slurry seal contract for the City of Harrisburg to the lowest bidder Asphalt Surfacing Company in the amount of \$109,996.00. Upon roll call, all members present in favor.

Business Item 4. Approve New FT Hire – Public Works. Motion Anez, seconded Tank to hire Jeremy Wendling as a full-time public works generalist at a rate of \$19.08 per hour with a \$35.00 cell phone monthly allowance. Upon roll call, all members present in favor.

Pietrus updated council on a program that Sioux Falls is implementing that would allow qualifying homeowners to get up to \$500.00 back from their property tax bill. It would be eligible to those

homeowners of free standing homes, twin homes or condos and the resident must have applied with the county for a freeze on assessment by April 1 of the preceding year. (Under state law the assessment freeze only applies to seniors over 65 and those defined as disabled under the Social Security Act and comes with restrictions on income and property value.) Council requested that Pietrus proceed with drafting an ordinance and present at a future meeting.

With no further business, a motion was made by Tank, seconded Maxwell to adjourn the city council meeting at 6:27pm. Upon roll call, all members present in favor.
