Business Item 2. Motion Wodzinski, seconded Maxwell to approve Resolution 2025-08 – Allowing Open Containers in a specified area of Harrisburg during specified times and dates – Harrisburg Days June 13-15, 2025. Upon roll call vote; all present in favor.

RESOLUTION NO. 2025-08

A RESOLUTION PERMITTING OPEN CONTAINERS IN A SPECIFIED AREA OF HARRISBURG DURING SPECIFIED TIMES AND DATES.

WHEREAS, the City of Harrisburg (the "City") has passed ordinance 5.0102 that reads as follows:

5.0104 Open Containers. It shall be unlawful to consume any beer or alcoholic beverage or to possess any glass, can or other container containing beer or any alcoholic beverage on which the seal has been broken, in any public place, vacant building, automobile, street, alley, sidewalk or place of amusement or business establishment not authorized to sell beer or alcoholic beverages, unless approved by the City Council.

WHEREAS, the City has determined that it shall permit the consumption of alcoholic beverages on specific City streets at specific times during the annual Harrisburg Days celebration.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Harrisburg, South Dakota, that it shall permit the consumption of beer or alcoholic beverages on specific streets at specific times subject to the requirements of this resolution.

BE IT FURTHER RESOLVED that consumption shall only be permitted on the following public places, portions of streets, and their adjacent sidewalks and right of ways:

- Columbia Street (North of Willow Street) to Foundation Drive
- Tracts 1-5 Replat of Hsbg School Add

BE IT FURTHER RESOLVED that no open container shall be permitted past barriers erected on the above streets and their adjacent sidewalks and right of ways;

BE IT FURTHER RESOLVED that only open containers purchased from establishments or permit holders licensed pursuant to SDCL 35-4-2(4) or SDCL 35-4-124 shall be permitted on the above streets and their adjacent sidewalks and right of ways;

BE IT FURTHER RESOLVED that open containers shall only be permitted on the following dates and times:

- June 13, 2025 11:00am June 14, 2025 1:00am;
- June 14, 2025 11:00am June 15, 2025, 1:00am;

BE IT FURTHER RESOLVED that no glass containers containing beer or any alcoholic beverage shall be permitted on the above streets and their adjacent sidewalks and right of ways; and

BE IT FURTHER RESOLVED that the City and/or law enforcement may in its sole discretion reduce the area where open containers are permitted and shorten the time during which open containers are permitted.

Resolution 2025 - 09

A RESOLUTION TO APPROVE THE FORMATION OF THE MEADOW RIDGE ROAD DISTRICT

WHEREAS the City of Harrisburg finds that the proposed Meadow Ridge Road District lies within its extra-territorial platting jurisdiction;

WHEREAS the establishment of such a district within the subdivision jurisdiction of the City of Harrisburg must be submitted to the governing body for approval in accordance with SDCL

WHEREAS the City of Harrisburg has no objections to the creation and incorporation of the proposed road district.

NOW. THEREFORE, BE IT RESOLVED by the Common Council of the City of Harrisburg that the proposed Meadow Ridge Road District, as described in the attached Exhibit A, is hereby approved by the Common Council for the City of Harrisburg.

Resolution 2025 - 10

A RESOLUTION TO ACCEPT PUBLIC INFRASTRUCTURE IN THE DEVITT FARMS ADDITION AS SHOWN ON THE ATTACHED EXIBIT.

WHEREAS the City of Harrisburg approved construction plans for the Devitt Farms Addition.

WHEREAS Harrisburg Heritage, LLC installed a sanitary sewer system (\$123,800), a water distribution system (\$180,900), a storm water drainage system (\$100,300), and streets (\$291,500) per the City approved plans; and

WHEREAS the public infrastructure was installed within public right of way under the City's jurisdiction or public easements in favor of the City; and

WHEREAS the City Engineer issued a Notice of Final Inspection attesting the Work furnished is acceptable and is in receipt of record drawings from Harrisburg Heritage, LLC; and

WHEREAS the public infrastructure was completed and occupied by the public in October of 2022 and all warranty obligations of Harrisburg Heritage, LLC are complete to the City Engineer's satisfaction.

NOW, THEREFORE, BE IT RESOLVED by the Common Council of the City of Harrisburg, South Dakota, that the City hereby accepts the public infrastructure completed by Harrisburg Heritage, LLC within the dedicated public right of way of Devitt Drive and Central Park Court, Tracts 2A and 3 of Devitt Farms Addition, and in dedicated public easements, as described in the attached exhibit, and shall hereafter be responsible for the care and maintenance of said improvements from the date of this resolution.
