Business Item 5. Motion Maxwell, seconded Larson to approve authorization for the Mayor to request a DANR to de-obligate funds from CW09 SRF loan, previously awarded for the Westside Trunk Sewer Extension Project. Upon roll call vote; all present in favor.

Business Item 6. Motion Wodzinski, seconded Kindt to approve Jennifer Walz application for flower bed with the condition of the clover being removed from the boulevard.
