Motion Wodzinski, seconded Maxwell to approve Ordinance 2025-12 an ordinance of the City of Harrisburg, SD rezoning lots 5, 9, 13, 14, and 16 of Block 2, lots 4 through 6, 8 through 10, and 12 of Block 3, lots 1,2 and 6 through 11 of block 4, lota 1a and 3 through 8 of block 5, lots 1 through 3, 5, and 6 of block 6 and lot 1 of block 7 of the Sunny Haven Estates Addition, City of Harrisburg. Lincoln County, South Dakota from Low – Density Residential (R-2) to single family detached residential (R-1) per the attached exhibit and amending the official zoning map of the City of Harrisburg. Upon roll call vote; all in favor.

Motion Kindt, seconded Maxwell to approve Ordinance 2025-13 an ordinance of the City of Harrisburg, SD rezoning a portion of the Paul Alan Addition, City of Harrisburg, Lincoln County, South Dakota, from Single-Family detached residential (R-1) to Low density residential (R-2), per the attached exhibit, and amending the official zoning map of the City of Harrisburg. Upon roll call vote; all in favor.
