Jen Cleveland, on behalf of the City Planning office, presented a summary of the Conditional Use Permit for an Amendment to the Whiskey Creek Planned Unit Development to allow a Homeowners Association Community Building (Private Recreational Facility) with lessened setbacks allowing the structure to be seven feet from the rear property lines in this development, in addition to the previously approved standards modifications allowing accessory buildings not to exceed 3,000 square feet. Chad Huwe and Jen Cleveland spoke and answered questions from the Planning Commission. Kelly Nielson was present to speak and answer questions from the Planning Commission.
